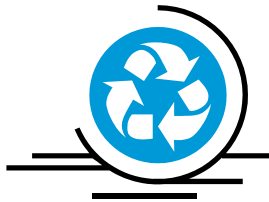


2ND Annual Yellow Dog Festival at Medlock Park October 14 10:00 AM to 4:00 PM

City of Decatur Hosts Electronics Recycling Day- Saturday, Oct. 21st

Save those old computers, printers, cameras, monitors and other paraphernalia, don't add it to the landfill!

The City of Decatur will host its 3rd Electronics Recycling Day on Saturday, October 21st, at the corner of McDonough St and Howard Avenue, in the **Decatur High School parking lot** from 9am to 1pm.

Anyone may bring items for recycling. In addition, you may bring:

- ✓ Batteries of any kind (they will be sorted on site)
- ✓ Mercury containing devices (thermostats and thermometers commonly contain mercury, and mercury is one of the most deadly of all environmental contaminants.)
- ✓ Ink cartridges and printer cartridges -- all can be recycled.

Traffic Calming, Sidewalks, and PATH:

We would like to thank the residents of North Superior (and any other residents of CHCA) who attended the Special Meeting on September 9th. There were many good questions and the meeting gave us an opportunity for those questions and concerns to be addressed.

TRAFFIC CALMING:

To address concerns about speeding in our neighborhood, individual residents have stepped forward to organize their neighbors to petition the county for traffic calming devices. People leading traffic calming initiatives in Clairmont Heights are John Maynard for North Superior Ave (jmaynard@tourou.edu or 404-315-0302), Anne Keller for Willivee Road (Keller.Anne@epamail.epa.gov), Melinda Yantch for Heritage Hills (tymy@bellsouth.net or 404-636-1355), and Emily Janke for Desmond Drive (emily.janke@gmail.com).

DeKalb County's procedure states that if there is consensus among residents on an individual street, their proposal will go to the Board of Commissioners who would presumably approve the request and then issue an official petition form. 65% of residents on that street would have to sign the petition within 90 days in order for the county to go ahead and install whatever devices are selected. John Maynard handed out copies of the county's traffic calming brochure and the county engineer's latest proposal for traffic calming on North Superior between North Decatur Road and Desmond Drive and took questions. SIDEWALKS:

The County has announced plans to install sidewalks in our neighborhood to meet their requirement for sidewalks within one mile of each school. Their plan calls for sidewalks on the south side of Desmond from Willivee to Clairmont, on the east side of North Superior from Desmond to North Decatur and on the west side of Willivee from Desmond to North Superior. We have been informed that the work will be completed by

MASON MILL PATH:

The proposed **PATH** trail starts as boardwalk at the Willivee Drive bridge then runs along the south side of South Fork Peachtree creek about 100 yards and then across the creek to Mason Mill Park. At that point it goes up a steep slope to the existing ridge trail where it becomes concrete and continues down across Burnt Fork Creek at the stone bridge then under the CSX railroad and ending at McConnell Drive near the Mason Mill Recreation Center. Users will be expected to park at Medlock Park or at the Mason Mill Rec Center parking lot. Jim Smith for the CHCA board said that because the Mason Mill Path segment was funded and no further community discussions scheduled, the project was essentially a "done deal" unless negotiations with one last property owner failed. Comments seemed mixed regarding the trail with most concerns raised about the environmental impacts and the County's use of eminent domain. On the Sunday following the general meeting, CHCA board members walked the route with Commissioner Gale Walldorff and submitted recommendations to minimize environmental damage and on formation of an oversight committee to advise PATH during design and construction. Traffic Calming Canvassing Time

We've now reached the point where it is time to canvass the North Superior homeowners to see if there is a consensus for an acceptable plan. The traffic calming measures, if approved, will only be placed in the County defined affected area from 538 North Superior to 791 North Superior. This is a total of 67 houses. A total of 44 homeowners in the affected area (65%) must sign the Board of Commissioners Issued Petition in order to have the measures installed.

A reminder: The cost of construction for the traffic calming measures is funded with money from the Transportation and/or the Capital Improvement Projects. The cost for maintenance of the measures will be paid for



by the property owners on North Superior @\$25 a year per homeowner (via property tax assessment).

Several of your neighbors have volunteered to deliver Traffic Calming Packets to the homeowners on North Superior. If someone hasn't already been to your home, you can expect to see them within the next week or two.
